Re: Notice Letter, Recycling Regulation RR152726, 2590 Granville Street, Vancouver, BC, Refuse

On July 2, 2020, Ministry of Environment and Climate Change Strategy, Environmental Protection Division staff conducted a desktop inspection of Call2Recycle to verify compliance with the Recycling Regulation under the *Environmental Management Act*.

Inspection Details:

Ministry of Environment and Climate Change Strategy (Ministry) Officer Pidskalney conducted a desktop inspection of the Call2Recycle Canada, Inc. (C2C) 2019 Annual Report to verify compliance with Section 8 of the Recycling Regulation (Regulation). C2C is a non-profit organization stewardship agency appointed to fulfill the requirements of the Regulation, Schedule 3, Electronic and Electrical Product Category. The stewardship plan covers dry-cell, primary and rechargeable consumer batteries sold as a standalone product or for replacement purposes only and weighing less than five (5) kilograms. C2C's stewardship plan was first approved on March 1, 2010, and the most recent amendment was approved December 12, 2018.

The inspection report period is from January 1, 2019 to December 31, 2019 and included a review of the following document(s):

- "2019 Provincial Annual Report British Columbia" (2019 Annual Report)
- British Columbia Extended Producer Responsibility Plan for Consumer Batteries (EPR Plan) November 2018

Details/Findings:	Section 25(5) of the Interpretation Act states, "If day specified is holiday or office closed, (1) If a day that is specified for doing an act falls on a holiday, the day falls on the next day that is not a holiday. (2) If a day that is specified for doing an act in a business office falls on a day on which the office is not open during regular business hours, the day falls on the next day the office is open during its regular business hours.
	As July 1, 2020, falls on a Wednesday and is a statutory holiday, the due date for the requirements in 8(1)(a) and (b) are Thursday, July 2, 2020.

Details/Findings:	Appendix G of the 2019 Annual Report contains the Audited Financial Statement and was prepared on May 20, 2020, by BDO Canada LLP. As C2C charges a separate fee on their products that is visible on the consumer's receipt (often called an "eco-fee"), the IAR fulfills Section 8(2)(f)(ii) of the regulation. C2C does not include a deposit/refund fee on the sale of their products and therefore Section 8(2)(f)(i) is
